Invitation for Bids

1. **Tanzania National Parks** (TANAPA) has set aside funds for its operation during the financial year **2009/2010**. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the procurement of various goods.
2. The Tanzania National Parks now invites sealed bids from eligible Suppliers of various goods.
 - i. Bid No. PA/037/2009-2010/HQ/GWND/01 for Supply of **Stationeries**
 - Lot No. 1 Supply of Office Stationeries
 - Lot No. 2 Supply of Printed Stationeries
 - ii. Bid No. PA/037/2009-2010/HQ/GWND/02 for Supply of **Promotional Materials**
3. Bidding will be conducted through the **National Competitive Tendering** procedures specified in the Public Procurement (Goods, Works, Non Consultant Service and Disposal of Public Assets by Tender) Regulations, 2005 – Government Notice No. 97 and is open to all Bidders as defined in the Regulations.
4. Interested eligible Bidders may obtain further information from and inspect the Bidding Documents at the office of **The Director General, Tanzania National Parks, Mwalimu J. K. Nyerere Conservation Centre/Building, Dodoma Road, P. O. Box 3134, Arusha**, from 08:00am to 4:00pm on Mondays to Fridays except on public holidays.
5. A complete set of Bidding Documents in English and additional set may be obtained by interested and eligible Bidders on the submission of a written application to the address given under paragraph 4 above and upon payment of non-refundable fee of **Tshs. 50,000.00**. Payment should

be by **Banker's Draft**, payable to the **Director General, Tanzania National Parks, P. O. Box 3134, Arusha, Tanzania.**

6. All Bids must be accompanied by a **Bid Securing Declaration** in an acceptable form.
7. All bids in one original plus one copy properly filled in, and enclosed in plain envelopes clearly indicating Tender and Lot numbers must be delivered to the address given below at or before **2:00pm on 21.01.2010**. Bids will be opened promptly thereafter in public and in the presence of Bidders' representatives who choose to attend the opening ceremony at the TANAPA Headquarters, Arusha.
8. Late bids, portion of bids, electronic bids, bids not opened and not read out in public at the bid opening ceremony shall not be acceptable for evaluation irrespective of the circumstances.
